Fees and Tuition for SY 2025-2026

Fees

- **Application Fee:** There is a \$100.00 non-refundable application fee that is due with the Application for Admission and all other required paperwork. This fee covers administrative costs associated with the application process.
- **New Family Deposit:** New students will be notified of acceptance status via email. A \$300.00 non-refundable enrollment fee will be required in order to secure the space for the student for the upcoming school year. This fee covers administrative costs associated with the enrollment process as well as educational materials such as textbooks and classroom supplies that are provided to the students each year.
- **Re-enrollment Fee:** All students must re-enroll each year to secure a space at Saint Mary-Sacred Heart School for the upcoming school year. There is a yearly re-enrollment fee required per child. This fee covers administrative costs associated with the enrollment process as well as educational materials such as textbooks and classroom supplies that are provided to the students each year.
 - **The Re-enrollment Fee for the 2025-2026 school year is \$300.00.**

All fees are paid online via your FACTS family portal account.

Tuition

Saint Mary-Sacred Heart School was created as a consolidated school in 1972 to serve and educate the students of the three Catholic parishes in North Attleboro. Today those churches are united as Transfiguration of the Lord Parish. We happily welcome students from many other parishes and other faiths.

- **Little Saints Pre-Kindergarten Program:** Our Pre-Kindergarten program is a full day program. All Pre-Kindergarten students will be charged the tuition based upon the number of days in the week they are enrolled regardless of whether or not the family is registered at Transfiguration of the Lord Parish, belongs to a parish outside North Attleboro, or is not registered at a parish.
 - 5 days = \$8,200.00
 - 3 days (MWF) = \$6,200.00
- **Grades K-8**
 - **\$6700** For students registered at Transfiguration of the Lord Parish
 - **\$6900** For students registered in a Catholic parish outside of North Attleboro
 - **\$7200** For students who are not registered in a Catholic parish

Financial Assistance

The Pastors of the Diocese of Fall River realize that the cost of educating children at a Catholic school may present a financial burden for some families. Saint Mary-Sacred Heart School is fortunate to be a product of Transfiguration of the Lord Parish that is committed to Catholic education. As a result, the parish offers families in need of assistance, and who are registered

(prior to January 1, 2025) *active* and *regular participants* in the parish, a subsidy of \$300.00 per student towards tuition costs. In order to apply for parish subsidy, you must also apply to FACE (see below).

Additionally, the Foundation for the Advancement of Catholic Education, FACE, encourages all our families to complete the online application for financial aid. The application window opened in mid-December and will remain open until March 31, 2025. To apply for FACE financial aid please go to www.online.factsmgt.com/aid.

- For parishioners of Transfiguration of the Lord Parish, you do NOT need to have the pastor's signature on the Parish Subsidy Request Form. Please complete the form and return it WITHOUT the pastor's signature to Mrs. Jillian Figueiredo.
- For parishioners of other parishes please contact your pastor directly for approval.

FACE Scholarships (Financial Aid)

- 2025-2026 FACTS applications for financial are now open.
- Applications are due by March 31, 2025.
- There is a \$45 per family non-refundable application fee.
- Schools will be notified of awards by the end of April/beginning of May.

Friends of SMSH Scholarships:

Once families have completed the FACTS Grant and Aid application, Saint Mary – Sacred Heart can also assist with tuition assistance. A formal request must be made by the family to the Principal.

The Friends of SMSH Scholarship Fund exists to support families who otherwise would not be able to send their children to Saint Mary-Sacred Heart School. We rely on the generosity of our donors and friends who help to provide this much needed assistance to our SMSH Families.

Tuition Payment Options

Tuition at Saint Mary-Sacred Heart School will be paid through FACTS using one of the following options:

FACTS Enrollment Fee: The Family will pay \$55 for the monthly payment plan, \$25 for pay in full. This is a non-refundable fee.

- **FACTS (10 monthly payments)**
 - Monthly Payments: May – February; 10th, 20th or Last Day of the month
 - Payments may be made with a bank account or credit/debit card. Payments made with a credit/debit card will be assessed a 2.95% fee paid by the family. No fee for a checking or savings account.



Fees and Tuition for SY 2025-2026 (cont.)

- **FACTS Tuition Annual Full Payment**
 - Pay In Full with 2% Discount: February, March, or April on the 10th or 20th of the selected month
 - Pay In Full with No Discount: May on the 10th or 20th of the month
 - Payments may be made with a bank account or credit/debit card. Payments made with a credit/debit card will be assessed a 2.95% fee paid by the family. No fee for a checking or savings account.

Withdrawals Tuition Refund Policy

- Enrollment fees are non-refundable and non-transferable.
- In the event of a student withdrawal or transfer from Saint Mary-Sacred Heart School for any reason, families will be responsible for a percentage of the total tuition for the year based upon the following allocation:

| Withdrawal Date Range | Family Financial Responsibility |
|-----------------------------------------------------------|-----------------------------------------|
| Enrollment Fee/Re-enrollment—before June 30 th | \$300 current student re-enrollment fee |
| July 1 st -July 31 st | 15% of tuition |
| August 1 st -1 st day of school | 25% of tuition |
| 2 nd day of school-November 30 th | 50% of tuition |
| December 1 st -December 31 st | 75% of tuition |
| January 1 st - End of school year | 100% of tuition |
